WHAT IS THIS PRODUCT

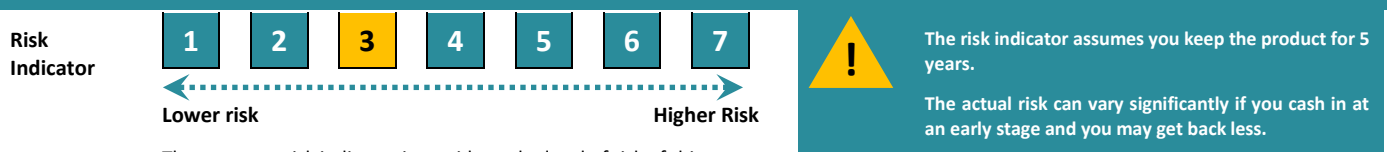
Type: The Company is a closed-ended investment company whose shares are listed on the London Stock Exchange and an alternative investment fund under the Alternative Investment Fund Managers directive. The Company’s shares are therefore available to the general public.

Objectives: To provide investors with a sustainable and progressive quarterly dividend and to aim to preserve and where possible enhance capital value through the reinvestment of excess cash flows, not required for the payment of dividends, in a diversified portfolio of predominantly UK ground-based solar PV assets. The Company will pursue its investment objective by acquiring ground based, operational solar power plants predominantly in the UK.

Intended retail investor: The Company is suitable for all investors seeking a fund that aims to deliver growth with a long-term horizon as a core or a component of a portfolio of investments. The investor should be prepared to bear losses and accept the risk inherent in the Company’s investment policy. The Company is compatible for mass market distribution.

Notes: The Company typically uses borrowing to acquire ground based solar power plants in accordance with the investment policy. The board of the Company intends that long-term structural borrowing will not exceed 40 per cent. of the Company’s gross asset value at drawdown, with a total leverage (which includes short term borrowing facilities) cap at 50 per cent. of the Company’s gross asset value. This will magnify any gains or losses made by the Company. Shares of Foresight Solar Fund Limited are bought and sold via stock markets. Typically, at any given time on any given day the price you pay for a share will be higher than the price at which you can sell it.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 3 out of 7, which indicates a medium risk class. Capital may be at risk as the value of investments may go down as well as up and therefore investors may not get back the amount originally invested. This product has no required minimum holding period, however five years has been used for the purposes of the calculations in this document. RECOMMENDED MINIMUM HOLDING PERIOD: 5 YEARS
